M5 J9 & A46 Transport Scheme – Public Engagement 7th October – 2nd December 2024

Completing the Public Engagement Survey

We have heard from the Gloucestershire County Council (GCC) project team that they've had approximately 550 responses to the survey. 75 responses haven't included postcodes. Of those returned with postcodes, only 26 responses are from the Teddington area with just 10 from the Alstone area. This is a really disappointing response. We know everyone has very busy lives but it will only take you about 5-10 minutes to complete (depending on how many comments you want to include).

If you haven't completed your survey yet, don't delay; you need to complete it by **Monday** 2nd **December** and remember, every member of your household can submit their own survey.
