Public Engagement Route Option Survey (GCC)

We have recently received the final count for the number of completed surveys submitted by our 2 villages. The total number of responses was 1085. Of those who provided a full postcode:

- Teddington: 124 responses across 7 postcodes (equivalent to 11% of total responses)
- Alstone: 29 responses across 2 postcodes (equivalent to 3% of total responses).

These are significant increases on the numbers provided previously; so, a really great effort by everyone concerned.

The full public engagement report will be published on Gloucestershire County Council's website later in the Spring.

Cotswold National Landscape (CNL) Submission

We have been provided with a copy of the route options public engagement submission from the Cotswold National Landscape Board. Surprisingly, they weren't told about the public engagement exercise, although they are statutory consultee. Their submission clearly shows that overall, they come down in favour of an alternative Option B that they have put forward for consideration. They also propose closing the A435 to traffic from seven bends to the Alstone Road/A435 junction.

Public Questions to GCC Council/Cabinet

We have raised a question for the next Full County Council Meeting in February to clarify if CNL's alternative route Option B and proposal to close to traffic the A435, will be assessed along with the existing 6 options as a potential short-listed option.

We have also raised a question at the next Cabinet meeting on 29th January to advise what happens if the Strategic Outline Business Case isn't approved and no funding from the Department for Transport (DfT) is forthcoming. Will GCC continue to fund the development of the next stage, or will the project be cancelled?
