Route Option Public Engagement Report

In our last newsletter, we advised that Gloucestershire County Council (GCC) would publish a summary of feedback from the Public Engagement this Spring. We have now been informed that this has been delayed until after the May local elections; sometime in Summer 2025.

Cotswold National Landscape (CNL) Submission

We previously informed residents about the late submission by the CNL Board to the Route Options Public Engagement. Their report can be found on our website here.

At the GCC meeting in February, we raised a question to clarify whether CNL's submission would still be considered. We received the following response:

"All the feedback from the M5 J9 and A46 (Ashchurch) Transport Scheme public engagement is being analysed, and a Report on Public Engagement will be published in Spring 2025. The issues raised by respondents will be considered in the next stage of scheme development. Refinements to the six options presented at public engagement will be considered including the impact of closing a section of the A435. The aim of the next stage of work is to reduce shortlisted options from 6 to 2 or 3, then confirm discounted options to stakeholders prior to completing detailed Outline Business Case development and appraisal. It is anticipated this work will take 12 to 18 months to complete."

Their proposals *will* therefore be considered, and we understand this will include traffic modelling to assess the impacts of the proposed revised Route B and the potential closure of the A435 to traffic.

We acknowledge the concerns recently raised by Beckford Parish Council regarding CNL's

proposal. They believe it will exacerbate the existing problem of tailbacks and gridlocked

traffic on the A46 through their parish. As mentioned above, traffic modelling will be

undertaken to assess the impacts. Hopefully, we will hear when the assessment and traffic

modelling has been completed and will then report back accordingly.

Ongoing Funding of the M5 J9 & A46 Transport Scheme project

At the January GCC Cabinet meeting, we asked what would happen if the Strategic Outline

Business Case (SOC) was not approved and no funding was secured from the Department for

Transport (DfT)? Would GCC continue to fund the next development stage or would the

project be cancelled? We received the following response:

"If the SOC isn't approved by the Department for Transport (DfT) and no funding from the DfT

is forthcoming, GCC will assess all options available before making a decision whether to

continue with the scheme."

A decision from the DfT was expected this month; however, it has once again been delayed.

Colin Chick, Executive Director of Economy, Environment and Infrastructure at GCC, recently

gave an update to Punchline, explaining why it was necessary for the Council to spend £10m

so far in developing the project in order to stand a chance of securing major government

funding.

At that time, he was expecting a decision from the DfT imminently. However, he has since told

us:

"We have not received any notification as yet in respect to the decision and it is unclear when

we are likely to."

So, it appears that GCC will have to continue funding the project themselves for the

foreseeable future or seek third-party funding, such as the £1million from the Community

Infrastructure Levy (CIL) Infrastructure Fund committee mentioned in the *Punchline* article.
